

# Thinking of choosing the apprenticeship path for Master 2?

You will need to respond to the OFL (Offre de Formation en Ligne= Online Training Choice) between 23rd and 30th January 2025.

If your career plan is already well structured and you have gained experience, you may consider applying for an apprenticeship programme during the OFL.

The apprenticeship programme offer will be available in December for the **2025-2026 academic year**.

If your career plan is not yet structured, we advise you to continue with the Full-Time Programme and develop your career plan and (related) experience during the internship periods (8 weeks in M1 & 16 weeks in M2)

## How do I apply for a Master 2 in apprenticeship format?

During the OFL, you will position the chosen apprenticeship programme as “wish 1”.

## What are the selection criteria?

- Your academic success (your last GPA)
- Your behaviour record during your studies at Rennes SB
- A CV highlighting your professional experience, with a title that clearly reflects the objectives of your career plan
- An apprenticeship job offer if you already have one

## Will you help me find a company to sign a work placement contract?

It is your responsibility to find a company. However, the school will assist and support you in your contract search:

- Information sessions on your apprenticeship training programme, and on the resources and tools you can use to develop an efficient and effective search
- Collective coaching sessions will be organised to help you present yourself and the apprenticeship contract option to the companies/organisations you have targeted
- Apprenticeship offers will also be made available to you every week on Jobteaser

## If I decide to do an apprenticeship, but I cannot find a company what will happen?

You will have the possibility to sign your contract up to 3 months after the start of the school year.

If you still wish to search for a company, the CFA team (Centre de Formation des Apprentis Apprenticeship Training Centre) will continue to support you.



If you have not signed a contract 3 months after the start of the school year, you can continue to follow the apprenticeship schedule but you will need to find an internship equivalent to 16 weeks. Please note the Programme will then be at your expense.

### **Is the apprenticeship done in France or abroad?**

The apprenticeship is a system specific to French legislation.

If your apprenticeship takes place abroad, you must be attached to a French company.

For international students, it is necessary to have a C1 level in French in order to be able to sign a contract with a company on your own.

### **Where should I enter the information to start the apprenticeship process?**

On JobTeaser/Toolbox/Alternance there is a link to a form to start the process. However, these links and the documents currently accessible are for 2024-25: they will be updated at the end of February/beginning of March for the 2025-2026 apprenticeship campaign

### **Can I already start looking for a company?**

Yes, finding a company will be an argument for your application. Moreover, some companies, especially in Finance, recruit their apprenticeship students as early as November.

### **What kind of position should I find?**

It must be a position that is in line with the level of your studies and the level of responsibility expected, in line with the objectives and content of the training programme you are following, and finally in line with your career plan: "Coherence and logic" are always the key words.

The apprenticeship mission must be in line with the job you are aiming for. You need to present to us the company/position proposal. If necessary, we will ask the company to expand on certain aspects.

There will be a special meeting for those who have made this choice during the OFL in January 2025.

### **If the company we work with is located in Paris, do we have access to the Paris campus during the course weeks?**

You will attend classes on the campus where you are accepted.
